Performance Evidence

Evidence required to demonstrate competence in this unit must be relevant to and satisfy all of the requirements of the elements and performance criteria on at least one occasion and include:

- assessing documents, answering lodgement questions and determining appropriate automatic entry process (AEP) codes
- assessing documents with required attention to detail
- assessing whether documents are compliant with the requirements of the purpose for which they are to be used
- ensuring currency of relevant legislative and regulatory knowledge
- ensuring documents being assessed for an import shipment correctly input AEP codes
- maintaining records in accordance with regulatory requirements
- reading and interpreting relevant Acts and legislation.

Knowledge Evidence

Evidence required to demonstrate competence in this unit must be relevant to and satisfy all of the requirements of the elements and performance criteria and include knowledge of:

- general awareness of biosecurity border clearance requirements
- obligations of person engaged in a regulatory arrangement
- policies regarding compliance with requirements of a regulatory arrangement
- relevant legislation, regulations, schemes, policies and procedures such as:
 - Automatic Entry Processing (AEP) for Commodities Scheme
 - minimum documentary and import declaration requirements policy
 - non-commodity information requirements policy
 - Non-commodity for Containerised Cargo Clearance (NCCC) Scheme.

Assessment Conditions

As a minimum, assessors must satisfy applicable regulatory requirements, which include requirements in the *Standards for Registered Training Organisations* current at the time of assessment.

Assessment must occur in workplace operational situations where it is appropriate to do so. Where this is not appropriate, assessment must occur in simulated workplace operational situations that replicate workplace conditions.

Assessment processes and techniques must be appropriate to the language, literacy and numeracy requirements of the work being performed and the needs of the candidate.

Resources for assessment include:

- a range of relevant exercises, case studies and/or simulations
- applicable documentation including workplace procedures, regulations, codes of practice and operation manuals
- relevant materials, tools, equipment and personal protective equipment currently used in industry.
