Evidence required to demonstrate competence in this unit must be relevant to and satisfy all the requirements of the elements, performance criteria and range of conditions on at least two separate occasions and includes:

- applying Work, Health and Safety (WHS)/Occupational Health and Safety (OHS) requirements including:
  - · emergency procedures
  - hazard identification
  - · risk control measures
  - safe working practices
- · communicating with personnel
- completing work as per scheduled requirements
- dismantling and assembling components
- identifying permit to work system requirements
- interpreting manufacturers' specifications and manuals
- · maintaining industrial screens, strainers and filters
- planning for industrial screen, strainer and filter maintenance work
- reading technical drawings and data
- removing industrial screens, strainers and filters for maintenance
- replacing and installing screens, strainers and filters
- using removal, maintenance and installing techniques and procedures
- · utilising valve levelling and alignment techniques
- working with measuring equipment and tools

## **Knowledge Evidence**

- installation and maintenance techniques

#### **Assessment Conditions**

As a minimum, assessment must satisfy applicable regulatory requirements, which include requirements in the Standards for Registered Training Organisations current at the time of assessment.

Assessment processes and techniques must be appropriate to the language, literacy and numeracy requirements of the work being performed and the needs of the candidate.

Assessment must occur in workplace operational situations. Where this is not appropriate, assessment must occur in simulated workplace operational situations that reflect workplace conditions. Resources for assessment must include access to:

- a range of relevant exercises, case studies and/or other simulations
- relevant and appropriate materials, tools, equipment and personal protective equipment currently used in industry
- applicable documentation including workplace procedures, industry standards, equipment specifications, regulations, codes of practice and operation manuals.
