# Assessment Requirements for UEPMNT419 Perform civil drafting

## Performance Evidence

Evidence required to demonstrate competence in this unit must be relevant to and satisfy all the requirements of the elements, performance criteria and range of conditions on at least two separate occasions and includes:

- applying Work, Health and Safety (WHS)/Occupational Health and Safety (OHS) requirements including:
  - emergency procedures
  - hazard identification
  - risk control measures
  - safe working practices
- communicating with personnel
- completing work as per scheduled requirements
- implementing legislation, industry standards, codes of practice and regulations
- performing drafting of civil structures
- preparing for drafting
- using technical drawings, plans, manufacturers' specifications and manuals
- utilising drafting principles including using civil drawing symbols
- working with computer aided drawing systems and equipment

## Knowledge Evidence

Evidence required to demonstrate competence in this unit must be relevant to and satisfy all the requirements of the elements, performance criteria and range of conditions and includes knowledge of:

- civil drawing symbols
- concepts and principles of drafting
- equipment for drawing and computer aided drawing systems
- legislation, industry standards, codes of practice and regulations
- technical drawings, plans, manufacturers' specifications and manuals
- typical arrangements of power production plant

- WHS/OHS legislated requirements including:
  - emergency procedures
  - hazard identification
  - risk control measures
  - safe working practices
- workplace documentation
- workplace policies and procedures

## Assessment Conditions

As a minimum, assessors must satisfy applicable regulatory requirements, which include requirements in the Standards for Registered Training Organisations current at the time of assessment.

As a minimum, assessment must satisfy applicable regulatory requirements, which include requirements in the Standards for Registered Training Organisations current at the time of assessment.

Assessment processes and techniques must be appropriate to the language, literacy and numeracy requirements of the work being performed and the needs of the candidate.

Assessment must occur in workplace operational situations. Where this is not appropriate, assessment must occur in simulated workplace operational situations that reflect workplace conditions.

Resources for assessment must include access to:

- a range of relevant exercises, case studies and/or other simulations
- relevant and appropriate materials, tools, equipment and personal protective equipment currently used in industry
- applicable documentation including workplace procedures, industry standards, equipment specifications, regulations, codes of practice and operation manuals.
