Assessment Requirements for UEPOPS061 Monitor and implement environmental site plans and procedures

Performance Evidence

Evidence required to demonstrate competence in this unit must be relevant to and satisfy all the requirements of the elements and performance criteria on at least two separate occasions and include:

- applying work health and safety (WHS)/occupational health and safety (OHS) requirements, including:
 - emergency procedures
 - risk control measures
 - safe working practices
- communicating with personnel and stakeholders
- implementing regulations, legislative requirements, codes of practice, manufacturers' recommendations and specifications, and environmental requirements
- managing environmental incidents, including:
 - assessing environmental risks of project, including impacts
 - controlling environmental incidents
 - integrating operational activities into review of environmental procedures
 - monitoring project and environmental site
 - using risk control procedures
- monitoring and reporting on application of environmental plans and procedures
- preparing to implement environmental plan and procedures
- reviewing application of environmental plans and procedures
- working with environmental plans and procedures.

Knowledge Evidence

Evidence required to demonstrate competence in this unit must be relevant to and satisfy all the requirements of the elements and performance criteria and include knowledge of:

- arrangements of power production plant
- environmental impact assessments
- environmental site plans and procedures
- identification of environmental risks and impact

- power generation plant and equipment, location and operating parameters
- project planning methods and techniques
- regulations, legislative requirements, codes of practice, manufacturers' recommendations and specifications, and environmental requirements
- WHS/OHS requirements, including:
 - emergency procedures
 - risk control measures
 - safe working practices
- workplace documentation
- workplace policies and procedures.

Assessment Conditions

Assessors must hold credentials specified within the Standards for Registered Training Organisations current at the time of assessment.

Assessment must satisfy the Principles of Assessment and Rules of Evidence and all regulatory requirements included within the Standards for Registered Training Organisations current at the time of assessment.

Assessment must occur in workplace operational situations where it is appropriate to do so; where this is not appropriate, assessment must occur in simulated workplace operational situations that replicate workplace conditions.

Assessment processes and techniques must be appropriate to the language, literacy and numeracy requirements of the work being performed and the needs of the candidate.

Resources for assessment must include access to:

- a range of relevant exercises, case studies and/or other simulations
- relevant and appropriate materials, tools, equipment and personal protective equipment (PPE) currently used in industry
- applicable documentation, including workplace procedures, equipment specifications, regulations, codes of practice and operation manuals.
