#### **Performance Evidence**

Evidence required to demonstrate competence in this unit must be relevant to and satisfy all the requirements of the elements, performance criteria and range of conditions on at least two separate occasions and includes:

- analysing water system plant faults using analysis techniques and tools
- applying Work, Health and Safety (WHS)/Occupational Health and Safety (OHS) requirements including:
  - emergency procedures
  - risk control measures
  - safe working practices
- communicating with personnel
- completing documentation using recording procedures
- complying with legislation, industry standards, codes of practice and regulations
- identifying water system plant status
- interpreting manufacturers' specifications and manuals
- monitoring and inspecting water system plant operations
- operating water system plant
- organising resources
- preparing and planning work
- preparing plant and equipment for operation
- recognising and responding to abnormal water system plant operating conditions
- testing water system plant operationally using diagnostic and test techniques
- working with permit to work system

## **Knowledge Evidence**

Evidence required to demonstrate competence in this unit must be relevant to and satisfy all the requirements of the elements, performance criteria and range of conditions and includes knowledge of:

- inspection and monitoring plant water system
- legislation, industry standards, codes of practice and regulations

- manufacturers' manuals and specifications
- permit to work system
- safe operating principles
- water system plant and equipment, its location and operating parameters
- water system plant status including the identification of faults and abnormalities
- WHS/OHS legislated requirements including:
  - · emergency procedures
  - risk control measures
  - safe working practices
- workplace documentation
- workplace policies and procedures

#### **Assessment Conditions**

As a minimum, assessors must satisfy applicable regulatory requirements, which include requirements in the Standards for Registered Training Organisations current at the time of assessment.

As a minimum, assessment must satisfy applicable regulatory requirements, which include requirements in the Standards for Registered Training Organisations current at the time of assessment.

Assessment processes and techniques must be appropriate to the language, literacy and numeracy requirements of the work being performed and the needs of the candidate.

Assessment must occur in workplace operational situations. Where this is not appropriate, assessment must occur in simulated workplace operational situations that reflect workplace conditions. Resources for assessment must include access to:

- a range of relevant exercises, case studies and/or other simulations
- relevant and appropriate materials, tools, equipment and personal protective equipment currently used in industry
- applicable documentation including workplace procedures, industry standards, equipment specifications, regulations, codes of practice and operation manuals.
