Application

This unit describes the skills and knowledge required to singe a small stock carcase as part of the carcase dressing procedures.

This unit applies to those who work under general supervision in meat processing premises, who are required to singe the skin of pig or goat carcasses either manually or by monitoring an automated process.

All work must be carried out to comply with workplace procedures, according to state/territory health and safety and food safety regulations, legislation and standards that apply to the workplace.

Mandatory workplace requirements apply to the assessment of this unit.

Performance Evidence

An individual demonstrating competency must satisfy all of the elements and performance criteria in this unit.

There must be evidence that the individual has singed small stock carcasses as part of the dressing procedures, following workplace requirements, in a micro or larger meat processing premises.

There must also be evidence that the individual has completed two shifts on the job, fulfilling workplace requirements (these shifts may include normal rotations into and out of the relevant work task).

Mandatory workplace requirements

All performance evidence specified above must be demonstrated in a meat processing premises.

Knowledge Evidence

An individual must be able to demonstrate the knowledge required to perform the tasks outlined in the elements and performance criteria of this unit. This includes knowledge of:

- purpose of singeing
- workplace requirements for singeing
- quality assurance requirements for hair removal
- workplace health and safety hazards encountered with singeing, and how the associated risks are managed.

Assessment Conditions

Assessment of the skills in this unit of competency must take place under the following conditions:

- physical conditions:
 - skills must be demonstrated in a meat processing premises at workplace production speed
- resources, equipment and materials:

- personal protective equipment
 - carcases for singeing
 - equipment for singeing
- specifications:
 - task-related documents
- personnel:
 - access to team members and workplace supervisor or mentor.

Assessment for this unit must include at least three forms of evidence.

Assessors of this unit must satisfy the requirements for assessors in applicable vocational education and training legislation, frameworks and/or standards.
