Application

This unit describes the skills and knowledge required to remove recoverable meat from a head, including but not limited to cheek meat.

This unit applies to individuals who work under general supervision in a meat processing premises.

Performance Evidence

An individual demonstrating competency must satisfy all of the elements and performance criteria in this unit.

There must be evidence that the individual has boned the heads of carcasses in a micro or larger meat processing premises.

There must also be evidence that the individual has completed two shifts on the job, fulfilling workplace requirements (these shifts may include normal rotations into and out of the relevant work task).

Mandatory workplace requirements

All performance evidence specified above must be demonstrated in a meat processing premises.

Knowledge Evidence

An individual must be able to demonstrate the knowledge required to perform the tasks outlined in the elements and performance criteria of this unit. This includes knowledge of:

- workplace requirements for boning heads
- cutting lines for boning head
- knife skills for boning
- importance of maximising yield
- the range of customer specifications for head meat
- possible sources of contamination, and measures used to avoid it
- sterilisation techniques
- workplace health and safety requirements
- typical hazards encountered when boning head, and how the associated risks are controlled.

Assessment Conditions

Assessment of the skills in this unit of competency must take place under the following conditions:

- physical conditions:
 - skills must be demonstrated in a meat processing premises at workplace production speed
- resources, equipment and materials:
 - personal protective equipment
 - heads for boning
 - knife, steel and, where required, meat hook
- specifications:
 - task-related documents
- personnel:
 - access to workplace supervisor or mentor.

Assessment for this unit must include at least three forms of evidence.

Assessors of this unit must satisfy the requirements for assessors in applicable vocational education and training legislation, frameworks and/or standards.
