Application

This unit describes the skills and knowledge required to operate a wool pulling machine in a fellmongering operation.

This unit applies to individuals who work under general supervision in a fellmongering plant, who operate machinery to pull wool from sweated skins.

All work must be carried out to comply with workplace procedures, according to state/territory health and safety regulations, legislation and standards that apply to the workplace.

Mandatory workplace requirements apply to the assessment of this unit.

Performance Evidence

An individual demonstrating competency must satisfy all of the elements and performance criteria in this unit.

The assessor must observe the individual operating the wool puller to remove wool from 20 skins, following workplace requirements.

There must also be evidence that the individual has completed two shifts on the job, fulfilling workplace requirements (these shifts may include normal rotations into and out of the relevant work task).

Mandatory workplace requirements

All performance evidence specified above must be demonstrated in a fellmongering premises.

Knowledge Evidence

An individual must be able to demonstrate the knowledge required to perform the tasks outlined in the elements and performance criteria of this unit. This includes knowledge of:

- workplace requirements for operating wool pulling machinery
- operating requirements for pulling machine
- relevant safety procedures
- workplace health and safety hazards associated with wool pulling, and how the associated risks are controlled
- quality requirements for skins and pulled wool
- wool puller cleaning requirements.

Assessment Conditions

Assessment of the skills in this unit of competency must take place under the following conditions:

- physical conditions:
 - skills must be demonstrated in a fellmongering premises at workplace production speed

- resources, equipment and materials:
 - personal protective equipment
 - wool puller
 - skins with wool
- specifications:
 - task-related documents
- personnel:
 - access to workplace supervisor or mentor.

Assessment for this unit must include at least three forms of evidence.

Assessors of this unit must satisfy the requirements for assessors in applicable vocational education and training legislation, frameworks and/or standards.
