Modification History

Release 1. This is the first release of this qualification in the CSC Correctional Services Training Package Release 5.0

Qualification Description

This qualification reflects the role of individuals employed in the supervision and management of offenders and detainees. It allows for the attainment of general competencies, dog handling competencies or specialisations in supervision and leadership, case management, community or emergency response streams.

The general qualification covers competencies that reflect advanced practice and greater team leadership roles of experienced individuals.

The case management specialisation covers the competencies required by individuals responsible for case management of offenders in custodial or community settings.

The community specialisation covers the competencies required by individuals responsible for supervising offenders directly or indirectly in the community and within specified parameters of responsibility defined by work activities, or by the complexity of assessment offenders' needs and risks.

The emergency response specialisation covers the competencies required by individuals responsible for responding to and supervising serious incidents or events that occur within custodial settings.

The supervision specialisation covers the competencies required by individuals responsible for supervising staff and/or offenders in the correctional environment.

The dog handling elective group covers competencies suitable for individuals responsible for the maintenance of canine health and welfare and the utilisation of canines for detection and security purposes.

Statutory/legislative requirements apply to this qualification and may vary across states and territories. Users are required to check with the relevant jurisdiction for current requirements.

Additional qualification advice

Where a defined specialisation is completed as detailed below, the resultant testamur can be titled: Certificate IV in Correctional Practice (field of study) e.g. Certificate IV in Correctional Practice (Supervision).

Entry Requirements

There are no entry requirements for this qualification.

Packaging Rules

12 units of competency must be completed:

- 4 core units
- 1 health and safety elective unit from group A relevant to the job role
- 7 elective units consisting of:
 - units from either the health and safety elective units not already selected, or from any of the Groups below
 - Dog Handlers should complete at least three units from Group F and the remaining four from any of the Groups below
 - up to 2 elective units may be selected from this or imported from any other endorsed Training Package or accredited course, provided the selected units contribute to the vocational outcome of the qualification and do not duplicate content already covered. Where imported units are selected, care must be taken to ensure that any prerequisite units specified are complied with.

Where a pre-requisite unit is attached to a unit it is identified by this symbol ⊥.

Specialisations

Candidates may specialise in a specific stream by completing the core units and elective units from one of the following:

- Case Management specialisation = 4 core units, 1 Group A health and safety elective unit, 4 Group B units plus 3 Group G units
- Community specialisation = 4 core units, 1 Group A health and safety elective unit, 5 Group C units plus 2 Group G units
- Emergency Response specialisation = 4 core units, 1 Group A health and safety elective unit, 6 Group D units plus 1 Group G units
- Supervision specialisation = 4 core units, 1 Group A health and safety elective unit, 5 Group E units plus 2 Group G units

Up to 2 elective units may be selected from this or imported from any other endorsed Training Package or accredited course when selecting Group G electives.
