Qualification Description

This qualification reflects the role of emergency response and rescue team leaders or coordinators working in the mining, drilling, extractive, and civil infrastructure industries, who perform tasks involving a broad range of skilled applications in a wide variety of contexts, which involve the application of discretion and judgement in selecting equipment, services or contingency measures.

Licensing/Regulatory Information

Licensing, legislative or certification requirements that apply to emergency response and rescue work, including in resources and infrastructure, vary between states, territories and industry sectors. Users must check requirements with the relevant body before applying the qualification.

Entry Requirements

This qualification is limited to those who have completed:

RII30726 Certificate III in Emergency Response and Rescue, or equivalent.

OR

RII30719 Certificate III in Emergency Response and Rescue, or equivalent, AND
PUAFIR207 Operate breathing apparatus open circuit, or equivalent

OR

RII30719 Certificate III in Emergency Response and Rescue, or equivalent, AND
RIIERR303E Operate in self-contained regenerative oxygen breathing apparatus, or equivalent

Packaging Rules
