#### **Qualification Description**

This qualification reflects the role of mine managers who work in an underground coal mine who perform tasks involving a high level of autonomy and requiring the application of significant judgement in planning and determining the selection of equipment/roles/techniques for themselves and others. They are required to demonstrate the application of a broad range of technical, managerial, coordination and planning skills and implement safety management plans.

Licensing, legislative, regulatory and certification requirements that apply to this qualification can vary between states, territories, and industry sectors. Relevant information must be sourced prior to application of the qualification.

## **Entry Requirements**

There are no entry requirements for this qualification.

#### **Packaging Rules**

The following provides the packaging rules for this qualification, followed by the list of relevant units of competency.

Total number of units = 12

#### 9 core units plus

#### **3 elective units,** of which:

- one (1) must be chosen from Group A
- at least one (1) must be chosen from Group B
- no more than one (1) may be chosen from Group C
- no more than one (1) may be chosen from elsewhere within this training package, or from another endorsed training package, or from an accredited course.

All elective units selected from outside this qualification must reflect current occupational and learning outcomes of this AQF qualification level.
